REMARKS

*** Regulations of PFT leagues available at www.pft.org.pl.
The way the leagues are played is subject to change.**

- After the competition, each competitor/dancer will be awarded points (in the solo and duets category) in accordance with the rules of the PFT leagues. Points will determine in which league a competitor/dancer can participate in the next competition.
- The contestants' affiliation to a given league at the competition is determined by the points scored by the dancer/competitor in the previous tournament. In the absence of points scored (i.e. before the first start), the league of the dancer / competitor is determined by the coach on the basis of previous achievements and the level of advancement of the competitor.
- A trainer/instructor may submit a dancer/contestant to a higher league, omitting lower leagues.
- A trainer/instructor cannot report a dancer/contestant to a lower league when he/she was classified in a higher league.
- The duo's affiliation to a given league is determined by the lower league of the duo's partner.
- Leagues D and C are "permanent" leagues, ie after reaching the level of league D or C, it is not possible to return to a lower league.
In leagues B, A, S players who do not score the required number of points will be classified to a lower league for the next competition.
- The year of birth of the dancer decides about belonging to the age category (in duets the year of birth decides the older of the partners; the maximum difference cannot be more than 2 years).
- Duos in the E+D league can only appear once.
- In groups and formations in a given age category, a maximum of 50% of the younger dancers can dance age category. The age of junior dancers cannot be less than 2 years from the lower upper limit age category. (does not apply to the age category Adults 2)

HOW A LEAGUE COMPETITION IS PLAYED

Disco Dance (solo, duos), Disco Freestyle (solo), Hip-Hop (solo, duos) and PAI (solo) → dancers perform three times* in each round (organizer's music):

1. short collective presentation for familiar with music and dance space, the so-called "warm-up", not appreciated by the jury;
2. main "individual" presentation assessed by the jury, where the number of soloists/duos per floor depends on the age category and the league, e.g.
 - League E, D, C up to 6 soloists/duos
 - League B up to 6 soloists/duos in the qualifying rounds, in the final 2-3 soloists/duos on the floor
 - League A, S up to 6 soloists/duos in the qualifying rounds, in the final up to 1-2 soloists/duos on the dance floor.
3. "comparative" collective presentation assessed by the jury.

* if there are 2-3 entities in the E,D,C,B league → there are two presentations assessed by the jury ("individual" and "comparative"); if there is 1 entity → there is only one presentation evaluated by judging committee

- Dimensions of the dance floor: for solos, duets, groups, etc. 8m x 8m, formations min. 12m x 14m.
- The organizer DOES NOT PROVIDE safety pins for starting numbers!
- The organizer does not take care of the participants and does not insure them. The duty of care and insurance rests with the delegating institutions.
- The club, the dancer has the right to withdraw from the competition at any stage. Withdrawal from the Tournament does not result in the return of the entry fee.
- During the Tournament, the following will be open: medical point, buffet, car park (unguarded).
- Changing rooms are open - they are not closed or supervised, the organizer is not responsible for things left behind.
- The insurance of the players is carried out by the delegating institutions, which declare that they have such insurance of the players. The Organizer does not take care of the participants of the Tournament.
- **All dancers are required to wear sports shoes (or to dance without shoes) - "high heels" and other types of shoes that can damage or scratch the ground are not allowed.**
- The organizer reserves the right to combine categories.
- • The organizer's written consent must be obtained for advertising in any form.
- • During the Tournament, participants are required to strictly comply with health and safety and fire protection regulations. in force at the Ursynów Sports and Recreation Center, Arena "Ursynów" in Warsaw.
- • Participation in the Tournament is tantamount to expressing forever and unconditionally free consent to video and television recording of all presentations.
- • Protests only in written form will be accepted up to 15 minutes after the end of a given competition
